

FlexiPort Cuff and Accessory Warranty

Reusable Cuffs: 3-Year

Welch Allyn warrants the Reusable FlexiPort Blood Pressure Cuff, when new, to be free of defects in material and workmanship and to perform in accordance with manufacturer's specifications for a period of **three years** from the date of purchase from Welch Allyn or its authorized distributors or agents. Welch Allyn will either repair or replace any components found to be defective or at variance from manufacturer's specifications within this time at no cost to the customer. It shall be the purchaser's responsibility to return the FlexiPort Blood Pressure Cuff to Welch Allyn or an authorized distributor, agent, or service representative. This warranty does not include breakage or failure due to tampering, misuse, neglect, accidents, modification, or shipping. This warranty is also void if the instrument is not used in accordance with manufacturer's recommendations or if repaired by other than Welch Allyn or an authorized agent. Purchase date determines warranty requirements. No other express warranty is given.

Disposable Cuffs: Warranty Void When Used

Welch Allyn warrants the Disposable FlexiPort Blood Pressure Cuff, when new, to be free of defects in material and workmanship and to perform in accordance with manufacturer's specifications. Welch Allyn will either repair or replace any components found to be defective or at variance from manufacturer's specifications when new at no cost to the customer. It shall be the purchaser's responsibility to return the FlexiPort Blood Pressure Cuff to Welch Allyn or an authorized distributor, agent, or service representative. This warranty does not include breakage or failure due to tampering, misuse, neglect, accidents, modification, or shipping. This warranty is also void if the instrument is not used in accordance with manufacturer's recommendations or if repaired by other than Welch Allyn or an authorized agent. Once used, this warranty is void. No other express warranty is given.

FlexiPort Accessories: 1-Year

Welch Allyn warrants the FlexiPort Blood Pressure Cuff Tubing and Fittings, when new, to be free of defects in material and workmanship and to perform in accordance with manufacturer's specifications for a period of one year from the date of purchase from Welch Allyn or its authorized distributors or agents. Welch Allyn will either repair or replace any components found to be defective or at variance from manufacturer's specifications within this time at no cost to the customer. It shall be the purchaser's responsibility to return the FlexiPort Blood Pressure Cuff to Welch Allyn or an authorized distributor, agent, or service representative. This warranty does not include breakage or failure due to tampering, misuse, neglect, accidents, modification, or shipping. This warranty is also void if the instrument is not used in accordance with manufacturer's recommendations or if repaired by other than Welch Allyn or an authorized agent. Purchase date determines warranty requirements. No other express warranty is given.
